

## **Mrs Dickens + Charles Dickens Museum Prize Draw Terms and Conditions**

1. This Prize Draw is being organised by The Orion Publishing Group (the 'Publisher'), Carmelite House, 50 Victoria Embankment, London EC4Y 0DZ.
2. This Prize Draw is for the chance to win two tickets to the Extra/Ordinary Women exhibition at the Charles Dickens Museum and two hardback copies of *Mrs Dickens* by Emily Howes 9781399610834 (the 'Prize'). No travel or accommodation is included in the prize.
3. To enter the Prize Draw, please follow @dickensmuseum, @phoenix\_books and @emilyhowesbooks on Instagram, like the relevant post and tag the person you'd share the prize with in the comments. Please do not include any sensitive personal data with your entry. No purchase is necessary to enter.
4. The winner of the Prize Draw (the 'Winner') will be selected at random from the entries received in accordance with these Terms and Conditions by The Orion Publishing Group, whose decision will be final. No correspondence will be entered into.
5. Entrants must be aged 18 or over and resident in the United Kingdom. The Prize Draw is not open to employees of the Publisher or the Charles Dickens Museum, their families, or to anyone professionally connected to the Prize Draw either themselves or through their families.

Entries may only be submitted between 4pm BST on Tuesday 16<sup>th</sup> June 2026 and 4pm BST on Tuesday 7<sup>th</sup> July 2026 Any entries received outside these specified times and dates and any entries that do not meet the requirements of these Terms and Conditions will not be eligible for entry to the Prize Draw.
7. An entrant may only submit one entry. Further entries will be disqualified. Entries will not be accepted via agents, third parties or in bulk.
8. The Publisher is not responsible for contacting or responding to entrants who provide unclear or incomplete information or for entries that are lost, misdirected, delayed or destroyed.
9. The Publisher reserves the right to (i) cancel the Prize Draw; (ii) alter the details of the Prize and/or (iii) alter any other details of the Prize Draw without notice but the Publisher will try to avoid

creating any undue disappointment. No cash alternative or other alternatives to the Prize will be provided.

10. If a Winner is unable to accept their Prize or cannot be contacted, the Publisher reserves the right to select another entrant to receive the Prize.
